- Family members can enroll at different times of the year. However, the end of the benefit year will remain the same for all family members; plan expiration will be 365 days from the first family member's enrollment date. Family members include parents, legal guardians and children 18 and under.
- All treatment must be paid in full at each visit to keep the plan in effect. No exceptions.
- Any benefits not used in an enrollment year can not be carried over.
- Family members cannot be substituted for other family members. Enrollee's name must be stated at the time of enrollment. This plan is non-transferable.
- This is an In-House Dental Plan and is NOT dental insurance. It cannot be combined with any other discount or dental insurance.

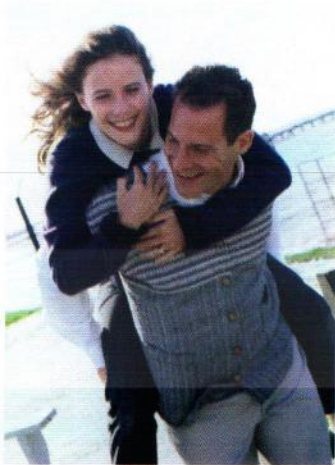
